

## **Claim for Block Incentive Payments**

Block incentive payments are payments for midwifery services, over and above any course of care payments that may have been made to you by the MPG. Block incentive payments are top-up clinical care payments made to the locum midwife where there have been fewer than four births during the locum period.

Block incentive payments are \$200 for each day of midwifery services provided, up to a maximum--between these payments and the course of care payments--of what a midwife would earn if they were working full-time in a regular practice situation (i.e., 4 BCCs every 4 weeks, minus operating and second fees).

The charts attached show how block incentive payments are calculated, depending on the number of course of care payments made by the practice group and the fee level of the locum midwife.
