Policy Analyst, Advocacy and Member Engagement

Reporting to the Manager, Policy and Communications, the Policy Analyst:

- Analyzes issues, conducts research and drafts reports to tackle problems and provides timely, strategic advice and solutions on key issues including closing the gender pay gap and pay equity, collective bargaining and reproductive rights.
- Analyzes and interprets information, writes persuasive proposals and presents work to diverse audiences.
- Leads consultation and engagement through key informant interviews, focus groups, webinars and committees and task forces.
- Develops policy recommendations, drafts action plans and collaborates with members and stakeholders to implement government relations and advocacy campaigns.

Key competencies and areas of expertise

- Understanding of health equity and human rights and consistently integrates this knowledge into their work, including Indigenous cultural safety and anti-racism.
- Knowledge of midwifery and the health care system in Ontario, association environments and the current political landscape.
- Experience with political advocacy campaigns and government relations.
- Proven initiative-taker who can create work plans to achieve results.
- Exceptional communication and people skills, with an ability to present and explain policy to a wide variety of audiences, including politicians, civil servants, midwives and sector stakeholders.

- A relevant university baccalaureate degree or above or equivalent work experience.
